NLS Board Minutes — NLS Teleconference Minutes

The **June 8, 2008** teleconference call meeting opened at 8:05. Present - Tracy Schmidlin, Nanette Helgager (Nu), Dave Erdman, Jerry Lemcke, Katie Sistar, Judy Laabs-Foss, Bob Northrup, Pastor John Propst, and 2008 host committee representatives, Joyce Dickerson and Rick Knopf. Pastor John opened with prayer.

Web-Site Coordinator - Bob Northrup has worked diligently to transfer the website from Orin Gough's name to his name with alternate signers. The web site was down several times during this time and the domain name needs to be renewed. The possible time is 9 years. Tracy Schmidlin and Judy Laabs-Foss will be listed on the account so it will be easier to change when needed. *Jerry moved that Bob Northrup be authorized to renew the website domain name for the maximum amount of years allowed. Katie Sistar seconded. Motion carried.*

Bob and Judy will confer concerning specifics for the appropriate laptop to be purchased for the board's use before July.

Tracy welcomed Joyce and Rick joining us for this teleconference.

Host Committee Representative - Joyce stated that at this time there are 122 registered for the 2008 National Meeting plus about 25 for the host committee. The college will adjust costs when the numbers are finalized. The cost is currently based on 200 attendees. More registrations are expected as it gets closer to the meeting date. The host committee is excited and looking forward to people coming to Phoenix.

Good News Secretariat is presenting the Sponsorship Seminar. They have a power point and special handouts and are planning to include a team of five volunteers from those attending for this seminar.

The board discussed that it would be helpful if presenters had their own laptops to use.

The committee is working on a direct link for things to be run off at the meeting. The board's reports need to be in by June 25 to Joyce with a copy to Nu.

Lodging for the speakers was discussed. Their needs are taken care of.

Spiritual Director - John is asking pastors attending to participate in the Pastors' Seminar.

There is a need to fill the Essentials Seminar.

There was discussion that the banner committee meet again to make a banner for new affiliates. Lois Witham would be asked to lead it.

The board discussed when members would be arriving. Some of the board are arriving on Tuesday and will need a place to stay. Joyce will see if the college is available. Our first board meeting will be at 1:00 on Wednesday.

(At this point, Joyce and Rick signed off.)

VP Administration - Nanette Helgager (Nu) is getting regular reports from Joyce and the host committee. They were commended for doing a great job. Joyce has copies of the registration forms. She will update the numbers and send the board new lists. Nu will make sure everything is coordinated.

Treasurer - Jerry Lemcke - He noted that 13 secretariats have not paid their dues yet. He is following up on that with phone calls. Balance in the Wachovia account is

\$12,683.81. Balance in the Thrivent account is \$16,987.00. The interest rates are down.

VP Outreach - Dave Erdman - The board discussed having a committee with people from different regions to assist the VP of Outreach. The National Coordinator Position is not imminent so this would be a big help in having more contact with new groups and those interested in affiliating.

Journey of Faith has done its homework, formed a board, understands the essentials of VDC and has an interested core group. *Dave moved that Journey of Faith be affiliated with the National VDC. Jerry seconded. Board approved.*

There are groups in Oregon and Michigan that are interested in VDC.

Dave will follow up on that interest.

Secretary - Katie Sistar - She has completed the 2007 Survey with 45 out of 46 secretariats responding. The report includes the number of lay and clergy that attended weekends in 2007 and the number of weekends that were held. This report will be included in the packet in Phoenix.

Katie requested that a form be included in the packet that would emphasize the need for the local secretariats to update their information when new officers are elected and send it to members of the board so we will have an easier time contacting people for the information we need at different times during the year. Nu agreed to make this form.

Old Business - The need for pastoral support and making a better bridge for understanding between pastors and lay persons was discussed.

The nominating committee consists of two people - Blake Ozias of Washington and Ed Brostl of Colorado. As of this date the nominating committee has received one name for VP Administration, one name for Treasurer and three names for Spiritual director.

Tracy suggested that board members work on articles to be included in the newsletters at Nationals and give them to Judy ahead of time.

New Business - The board discussed that a pastor working on his doctorate asked permission to use the green card in his dissertation on a Balanced Christian Life.

Jerry moved that Pastor Tim Salo from Madison, NJ be allowed to use the green card in his dissertation. John seconded. Board approved.

Board will meet at 1:00 Wednesday, July 23, 2008 at Grand Canyon University in Phoenix.

Pr. John closed with prayer. Meeting adjourned at 9:55.

NEW Web Site Administrator

At the July 2008 NLSAM a request went out for the need to fill the Web Site position; **Larry Conway** stepped forth and was appointed to this position. Please welcome Larry!



Pastor Lawrence J. Conway, III was ordained in 1980 by the New Jersey Synod of the Lutheran Church in America and served two congregations in the Maryland Synod. While there, he was part of the Synods ecumenical team with responsibility for Western Maryland.

He began his military ministry in 1985 at the request of the former Lutheran Church in America to serve as a military Chaplain. His first tour was at Fort Hood with a support battalion. While at Ft. Hood, he started the Lutheran chapel service on the installation. Following this tour, he served in Giessen, Germany with an Air Defense Artillery unit for three years and began a Lutheran chapel service there. In 1991, following the 6 month long Chaplain Career Course at Ft. Monmouth, New Jersey, he went to Ft. Irwin, California. At Ft. Irwin, he served as a unit Chaplain with the OPFOR (Opposing Forces) for 35 month long National Training Center rotations and started the Lutheran service at that installation. In 1994, he was selected by the Army for advanced schooling in world religions and for promotion to Major. For his advanced schooling, he attended Princeton Theological Seminary, earning a Masters of Theology with a specialization in the history of religion.

After this year of schooling, he went to Ft. Leavenworth, Kansas, for attendance in the Army's Command and General Staff College year long course for mid grade officers. After graduating, he stayed there for three years to teach in the College's Department of Joint and Multinational Operations, serving as the school's subject matter expert for world religions and for religious conflict. While at Ft. Leavenworth, he also served as the Senior Pastor of the Lutheran service on the installation. In addition, he was the first departmental web master for his teaching department and received an

award from the Army for the 350 page site he created and maintained.

Following this tour, Pastor Conway then went to the Washington, DC area to become the regimental chaplain for the 3rd U.S. Infantry Regiment (The Old Guard). While there, he conducted Protestant services at Ft. McNair while being the chaplain for this famous unit that includes the Tomb of the Unknown Soldier guards and the US Army Fife and Drum Corps. While still in the DC area, he then moved to Arlington National Cemetery and served as one of two full time Funeral Chaplains, conducting three to five funerals a day for just under one year.

In 2001, he moved to Hawaii to serve as Deputy Installation Chaplain for the Schofield Barracks Installation Chaplains Office and was promoted to Lt. Colonel. This position involved the oversight of 33 worship services in eight chapels on two islands and a staff of 22 people in three locations. His duties also included chaplain training coordination and many other related tasks. While there, he was also Senior Pastor of the Protestant Service and later Senior Pastor of the Lutheran Service.

Pastor Conway assumed his current position as Command Chaplain for the Army Field Support Command, located on Rock Island Arsenal, in January of 2005. In April of 2005 he deployed to South West Asia, traveling to various locations in Iraq, Afghanistan, Qatar, and Kuwait. While deployed, he also served as pastor for the Lutheran service in Camp Arifjan, Kuwait. He then returned to his position at Rock Island Arsenal in September of 2005.

Pastor Conway retired from active duty in January of 2007 and accepted the call to serve as the Senior Pastor of Trinity Lutheran Church, Moline, Illinois. He began his ministry at Trinity in February of 2007 and remains in that position.

Pastor Conway is a native of the Philadelphia, PA area and has been married to his wife, Linda, for over 31 years. They are the parents of two adult children: Elizabeth, who is a first year student at Wartburg Seminary; and Jay, who lives and works as a bank manager in the Washington, DC area.

NLSAM — 2009 in Miami, FL



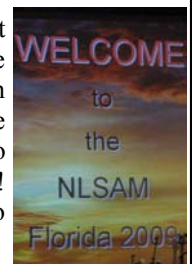

NLS Board Minutes — Annual Meeting Phoenix, AZ on July 24—27, 2008

Wednesday, July 23, 2008

Tracy called the meeting to order at 1:00 PM. Present: Tracy Schmidlin, Nanette (Nu) Helgager, Dave Erdman, Jerry Lemcke, Katie Sistar, Diane Purcell, Judy Laabs-Foss, Bob Northrup, Pr. John Propst Pastor John Propst read from the devotional book “God Calling” and led in prayer.

Tracy went over the schedule in detail and discussed procedures for the business meetings. Board discussed the possibility of requiring all the appointed board members to be present for the National Meetings, especially during our anniversary years of 2010 and 2011. It was suggested that if we require them to be there, we should pay their way. Past information and history of our organization needs to be gathered and reconstructed. Boxes of records were damaged beyond repair when shipped. Next year start a history table where people can contribute items that they have saved.

Diane Purcell will be parliamentarian. The board discussed procedures for the business meetings, including recognizing nominees and procedures for nominating people from the floor.

Katie Sistar proposed that this year we seat delegates by regions, including the new secretariat from Eastern Pennsylvania, Journey in Faith.

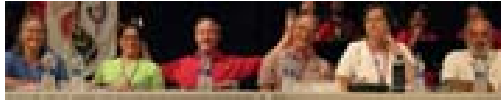
On Friday Tracy Schmidlin will accept nominations from the floor for the offices of Vice President Administration, Spiritual Director, and Treasurer. She will also ask for persons who are interested in being appointed as Website Coordinator/Manager to see either her or Bob Northrup.

The board will ask attendees to turn in names of good speakers and to indicate which subjects they can do well. We will emphasize that the Pastoral Support Seminar is open to delegates and visitors as well as pastors. Sponsorship Seminar has a video presentation of how to sponsor a candidate/pilgrim. A series of videos will be available for anyone to attend at any time.

Hosting for the next four years with Letters of Intent are: 2009–Florida, 2010–Minnesota, 2011–Western North Carolina, 2012–Colorado. 2010 will be the fortieth anniversary of when Iowa and Florida started Lutheran Cursillo. 2011 is the thirtieth anniversary of Na-

tional Lutheran Secretariat. We discussed the need for the host committees to indicate a good time for the board to be able to call them when e-mail isn’t sufficient.

We discussed the need for the National Coordinator Committee to continue to work and the need for a Visioning Committee to dream of possibilities five years or more down the road.



Announcements will include poster signing and availability of computers for attendees.

The new computer for the board is here. We discussed the need for all documents and records to be put on it, listing by years, including final minutes of meetings with a flash drive back up so our information will not be lost. *Nu moved that we purchase 2 flash drives to back up important information for NLS. Jerry seconded. Motion carried unanimously.*

We discussed needing a number of reporters for newsletter updates at National meetings. The offering taken at worship on Saturday night will go to fund Outreach. During worship there is to be no flash photography, and communion will be by intinction. Banners from the secretariats will be brought to the first business meeting and will be hung by the host committee. Eduardo Bonin tribute will be after supper on Saturday night.

We discussed the need for vendors to be non competitive with the host team. The use of the trademark needs to be protected. Diane Purcell will word a resolution concerning this.

We discussed that secretariats must have insurance. We discussed working together and meeting deadlines.

The NLS Constitution needs to be added to the library. The Pilgrim’s Guide is in Braille, but it is not being used. People need to be aware that it is in the library.

Meeting closed at 5:00 PM. Meeting reconvened at 7:15 PM.

The host team will pick up banners as delegates bring them up when they are seated. Katie Sistar will call out delegates from each region to be seated

by the host committee in designated seating. Nu Helgager will make a power point list of everyone’s names. We need to be clear on the names. We need a delegate’s list that is a different one from the roster of attendees.

We went over room numbers and announcements to be made.

It was suggested that Dave Erdman and a contact person from each region contact secretariats that did not attend the national meeting in 2007 or 2008.

We discussed needing a committee with representatives from the west Coast, middle section and the east Coast to help Dave with outreach.

Nu Helgager has included a form in the packet for secretariats to let us know when there is a change of officers in the secretariats.

We discussed who should keep the records. The secretary keeps the corporate minutes. We need to reconstruct back as far as possible since the records shipped by UPS were destroyed. We could look for old records, newsletters, ask former secretaries, and ask if past members have any records that would help with our history.

We discussed fundraising and endowments. We would like to be under ELCA Foundation as an approved organization to be listed in people’s wills.

We need a million and a half dollars to endow the National Coordinator Position. We need to get secretariats to update their lists, indicate deceased persons or those who have moved, etc. to help us get a database to work with.

The year ends on May 31 for finances. We as a board need to make a point of getting things done as early as possible. Board was in consensus for the VP Administration to add travel to hosting location about two months before the national Meeting to review final details, schedules, and plans to assist both the Host Committee and the Board in making final preparations for the NLSAM and to be prepared for our first meeting when we arrive for the NLSAM. We agreed to increase the VP of Administration’s budget for the travel. Housing for this additional visit by the VPA would be provided by the Host Committee.

Nu Helgager has the hosting contract from Florida. Meeting adjourned at 8:20 PM. Pr. John Propst closed with

Thursday, July 24, 2008

The National Lutheran Secretariat Meeting was called to order by the president, Tracy Schmidlin at 3:35 PM. Tracy asked all the first timers to stand up, and then recognized delegates that have attended Nationals multiple years. Carroll Lang has attended 28 of the past 31 years. Pastor John Propst led in prayer.

Shannon Landers from the university extended a warm welcome to Cur-sillo/Via de Cristo to Grand Canyon University in Phoenix, Arizona.

Tracy introduced the board and three of the seven appointed members. Tracy



Schmidlin, Nanette Helgager, Dave Erdman, Jerry Lemcke, Katie Sistar, Pastor John Propst, Diane Purcell, Judy Laabs-Foss, and Bob Northrup were present. Past board members that were present were recognized.

Tracy explained that the delegates would be seated this year by regions. Katie Sistar called their names to be seated by the hosts while a power point listing of their names prepared by Nu Helgager was shown.

Dave Erdman introduced the new secretariat "Journey in Faith" from Eastern Pennsylvania, and praised Region 5 for helping them become part of the National Lutheran Secretariat.

Tracy recognized the nominating committee, Ed Broestl and Blake Ozias. Ed Broestl named the nominees for the three positions open this year. VP of Administration - Nanette Helgager, Spiritual Director - Pr. Charlie Carlson and Pr. Doug Givan, and Treasurer - Bob Northrup. Tracy explained that nominations could be made from the floor following the guidelines as explained and listed in their books. She also noted that the Website Coordinator/Manager Position needs to be filled at this time. Job descriptions are in their books.

Pastor John Propst encouraged visi-

tors and delegates to attend the Pastors Seminar in hopes of a lot of discussion and helpful information to encourage pastors to be involved in this movement.

Newsletter Editor - Tracy told about the newsletter editor's job. Judy Laabs-Foss will have summaries of the minutes, meetings, and worship in the daily Conexiones.

Katie Sistar noted the information gathered on the 2007 Survey Form in their books.

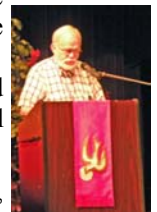
Tracy went over rules for nomina-

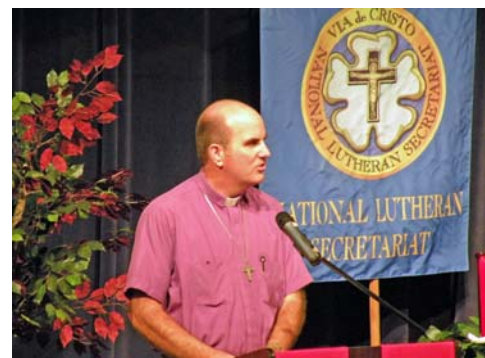

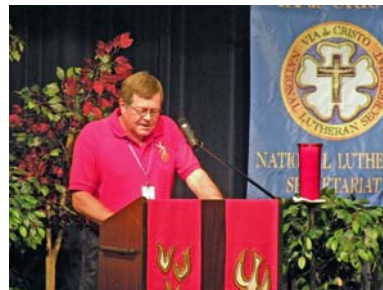
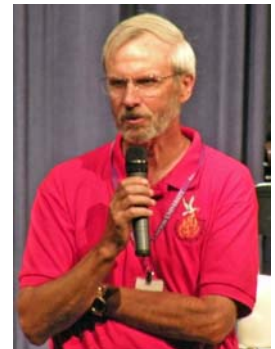

Continued from page 7 vendors. Any sale or use of materials and logo are to be for the benefit of the local secretariat and NLS for fund raising purposes. The board is working on wording a formal resolution concerning this.

The candidates for VP of Administration, Spiritual Director, and Treasurer were introduced again. The voting process was reviewed. Two delegates had to leave early, so 88 ballots were passed out and collected. Two past presidents, Doug Burrows, and Larry Witham, along with Ed Broestl, a member of this year's nominating committee, were requested to count the ballots.

During that time, attendees were encouraged to complete the evaluation forms and turn them in. They were requested to list names of good speakers on 3x5 cards and write a comment as to their topic or area that they do well and how to contact them.



Each of the regions had a speaker give a summary of their Region-to-Region discussions. They have turned in or will turn in written reports summarizing their discussions. Nancy Peterson from Minnesota in **Region 2** said they discussed lots of information to take back to their secretariats and would use some of it in their Ultreyas. Cindy Perkins from Oklahoma in **Region 3** said they had learned that movements are different and that some have co-ed weekends with different tables. She commented that some pastors from their synod have moved to other areas. Linda Erdman from Inky in **Region 4** spoke. They want to try to have better communications and go for a website to share more about the weekends. Pr. Paul Schmidlin from Ohio in **Region 5** stated their group discussed how they could work together better. They want to continue to encourage Journey in Faith and to ask members of NLS to forward names of people who have moved to their area. They have sched-

uled a regional meeting to assist Journey in Faith in their first weekends in the spring. Vivian Knight from South Carolina in **Region 6** said that after Los Angeles, they had a regional secretariat meeting and repeated it this year. They had a music workshop and a financial workshop. They discussed inviting more people to come to Nationals. They were concerned that Georgia hasn't attended and will try to help them. We need to support each other's weekends with people, pastors, etc., sharing information. Dave Rankin from Florida in **Region 7** stated that there are 7 active secretariats in Florida, though some are struggling. They discussed how to support each other. Ed Broestl from Colorado in **Region 1** said they shared views, concerns and stressors. They discussed the question - What thing if it was left out would make life totally bearable? They saw a need to examine their insurance position. They want to get information back and forth better in their large area.

The results of the balloting were stated. Those elected were Vice President Administration - Nanette (Nu) Helgager, Pastor Doug Givan - NLS Spiritual Director, and Treasurer - Bob Northrup. *Donna Gough moved that the ballots be destroyed. Kris Jones seconded. Motion carried.*

All of the committees presented verbal or written reports with discussion and questions as necessary. Copies of most reports were passed out or in their books.

Banner and Palanca - Lois Witham facilitated the workshop and has a written report. The committee presented a beautiful butterfly DeColores banner to Journey in Faith delegates.

Finance Committee - Virginia Reyrmer read the report. Jim Ryan presented the budget as presented in the packet. They discussed the need to pass information about dues and the due date to new treasurers in the secretariats. There was concern that many secretariats had not paid their dues by May 31. Last year's amount of \$7000 was insufficient to begin the National Coordinator Fund Raising Campaign. In the new proposed budget there is a line item that states "Board authorized

to expend prior years accumulated unrestricted funds and fund raising designated funds for endowment fund raising." This would be up to \$13,000. *Ted Smith moved that the budget be approved as read. Bob Quam seconded. Motion carried.* Diane Purcell asked secretariats to make gifts to get the National Coordinator Campaign off the ground. Jerry thanked Minnesota for their palanca gift. Offering at worship on Saturday night will go for Outreach.

Hosting an Annual Meeting - Nu Helgager has a written report. These are the secretariats that have made a formal commitment to host the annual meeting for the next four years. FL - July 23-26, 2009, MN - July 22-25, 2010, Western NC - July 28-31, 2011, VdC of the Rockies, CO — July 26-29, 2012.

Lay Director's Dialogue - Tracy Schmidlin facilitated this dialogue. A very important item from the written report is that all secretariats need to be insured and incorporated. There were many suggestions discussed among the 22 secretariats represented here.

Website Coordinator - Bob Northrup stated that there is one person who has expressed an interest in being the new Website Coordinator.

Newsletter Committee - Judy Laabs-Foss has a written report. They brainstormed about communication. She reminded delegates that she is available to be contacted throughout the year with any questions or problems concerning this form of communication within their secretariat.

Spiritual Director Dialogue - John Propst has a written report. There was good discussion among twelve secretariats about audio-visual aids, requiring clergy critiques, and things that are different in the country. One group suggested that a short 5-10 minute DVD with testimonies from pastors and bishops telling of the benefits of this movement would be a good item to share with pastors to increase interest.

Visioning Committee - Dave Damien was the facilitator and has a written report. They started by looking at priorities and then current circumstances. The committee noted that growth

seems to have slowed among a lot of secretariats, especially drawing pilgrims under forty. Prison ministries are fast growing. We need to have an influence in Christian ministries. They would like to implement positive changes. They see a need for outreach, for better communication, and to be flexible.

National Coordinator Campaign - Pr. Joe Nilsen stated that the need for a National Coordinator has been an evolving development over several years. Over 92,000 people have been through the movement in 47 secretariats. We need to permanently finance a paid position and past delegates voted to do this. We have not moved as rapidly as we hoped. This kind of campaign is very expensive. God led them to an answer. A consultant with 30 years fundraising experience who has seen changed lives from an Emmaus Walk has agreed to train us to do our own campaign. He will only charge us a per diem fee for three intense days of training and some expenses for utilization of some data resources. A properly run campaign will probably yield more than enough to fund the position. The committee will work with the board in working out details. They have been good stewards of the \$7000 that was authorized; they have only spent \$35.00 for a conference call to get this far. He made three requests: 1. Pray for this campaign. 2. Authorize the board to launch the campaign with up to \$13,000. 3. Go back to your secretariats and report these developments, and tell them we will be contacting them in the coming months to obtain a copy of their database. We must have a secure national database for the campaign to work. That will be used only for this campaign and then be secured in our national office.

Diane Purcell stated that the amount was approved when we approved the budget.

Tracy called for acceptance of the Letters of Intent for hosting. There is already a contract from Florida. *Carlene Lemcke moved that we accept the Letter of Intent from Minnesota for 2010. Jim Ryan seconded. Motion carried. Steve Barnett moved that we accept the Letter of Intent from North Carolina for 2011. Doug Burrows*

seconded. Motion carried. Gina Ford moved that we accept the Letter of Intent from Colorado for 2012. Roy Fredbloom seconded. Motion carried.

Florida's Secretariats extended an invitation for all to COME to Florida next year. Chip Spear narrated a DVD presentation showing Florida attractions and Barry University in Miami Shores. The theme is "One in the Son," based on John 17:21. The Florida delegation passed out invitations and bags of Florida pamphlets as attendees left the auditorium.

Diane Purcell moved to adjourn the NLS Meeting. Markay Neumann seconded. Motion carried. Pr. Joe Nilsen led a closing prayer.

Host Committee Meeting:

The seed money from the board has nothing to do with Arizona's funds.

Host team needs webmasters no later than January.

Vendors at the meeting are for the host's benefit and must be approved by the board. They cannot be in competition with Symbols, Inc.

Worship committee can plan worship. Send a copy to Pr. Doug Givan. Worship here in Phoenix was a good standard with the seven services.

Run the music by the Spiritual Director. Encourage a varied selection. Check on copyright of music. Band doesn't have to be approved. They can select whom they want.

Any issues that come up, let us know.

Lucy Hightower has the secretariat members' names in her computer's database.

Invitations to next year's meeting will be sent to all the attendees from this year.

The board trusts the host committee planning. Any questions you e-mail to Nu Helgager, also CC them to Tracy and the co-chairs, so the leaders know what is going on.

Florida requested that Mid-Year be scheduled for Nov.7-9, 2008 and that date was approved.

In planning copying, be flexible. It's not a good idea to use the college's copiers. There is a lot of copying ahead of time and at Nationals. Dave Rankin stated that he knows someone who can donate some copy machines to use for the meeting.

There were no other questions. Tracy closed the meeting with prayer at 5:05 PM.

"What me worry?"**

"Be anxious for nothing ..." Paul writes from prison to the Philippians. He then adds the infamous "but" and follows it with "in everything by prayer and supplication, with thanksgiving, let your requests be made known to God." (Philippians 4:6 NASB) Paul knew that prayer was the key to the relationship with God and receiving blessings. From prison he also wrote to the Ephesians "With all prayer and petition pray at all times in the Spirit, and with this in view, be on the alert with all perseverance and petition for all the saints." (Ephesians 6:18 NASB). In a pastoral letter to Timothy, he provides these words of instruction "First of all, then I urge that

entreaties and prayers, petitions and thanksgivings be made on behalf of all men, ..." (1 Timothy 2:1 NASB) When thinking of the words "Be anxious for nothing ...", I am reminded of "What me worry?" uttered by Alfred E. Neuman. Maybe Alfred knew of Paul's words. I remember my life before Christ when worry was a part of my daily routine, unlike Alfred. Life in Christ means a relationship where the worries are now placed in His hands through frequent prayers daily. It is intriguing that Paul wrote from a Roman prison where one would expect worry – "Be anxious for nothing ..." The words in Philippians 4:7 provide the solution to the intrigue "And the peace of God, which surpasses all comprehension, will guard your hearts and your minds in Christ Jesus."

It is the prayers of His people that bring us closer to Him. It is through prayers we find the solution. In Via de Cristo, it is these prayers which are the true palanca for the weekends, other activities of our communities and the lives of our Cursillistas. The Palanca offered up to Him last year are evident in the successes shown in the following report. May all the praise and thanksgiving for the achievements be in His name and bring glory to Him.

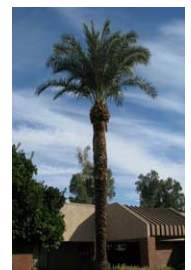
